The tenders of defaulting contractors, whose names have been published in various News papers under this office No: SDA/VC/9232-37 dated: 7/1/1999, shall not be entertained till the outstanding are liquidated/ reconciled and necessary N.O.C issued by the FA/CAO, SDA and those contractors, who have failed to execute the on going works within the stipulated time period.

Service tax shall be deducted at source as per the rates in vogue at the time of payment.

All terms and conditions will be same issued vide this office No: SDA/EE/300-06 dated: 20/01/2004 and as per PWD Form: 25

01. The intending tenderer should have to paste transparent cello tap on of each and every rates written on tender.
02. The documents will be issued on production of valid Registration card/Certificate only and an attested copy of the same to be submitted for office record.
03. The contractor shall have valid TIN / PAN/GST Registration and attested copy of the same to be submitted with the tender otherwise tender will be straightway rejected.
04. In case of any delay on the part of contractor a penalty upto 10% shall be imposed.
05. The bids shall remain valid for 90 days after opening of tenders
06. Defect liability period of the work shall be (12) months after completion of work.
07. If the bid of the lowest bidder is found unbalanced, the bidder shall have to produce additional performance security in the shape of CDR/FDR/BG immediately after opening of price bid as per following breakup:-
